New Member Terms and Conditions

1. The offer is open to new Willoughby Leisure Centre members, previous members, pass holders and casual users of Willoughby Leisure Centre.
2. Employees of the Willoughby Leisure Centre and Willoughby City Council and their families are ineligible to receive the offer.
3. Offered one time only per person.
4. All new members will be required to complete a general medical questionnaire and must warrant (by signature) that they are physically able to engage in exercise and fitness programs at the Centre (WLC).
5. Customers must be 16 years of age or older to sign up for the offer.
